SUMMARY BACKGROUND

Thirteen years ago, I filed (through a lawyer) a LMRDA Complaint at the same time that the D.N.C. was taking a bribe from Arthur Coia's 1961(4) OCCA/RICO Enterprise (at the time LIUNA had a 30 billion dollar pension worth). In those thirteen years, I experienced multiple types of Judicial Fraud, which you were part of insidiously and covertly directed by former U. S. Attorneys who were now Federal Judges. Not only did these judges corrupt the Judicial System to a banana republic level, they influenced a silent press shield as all banana republics¹ do. Not only are illegal immigrants coming over the border, the illegal and corrupt Judicial System is also coming over the border.

The Second Circuit is also culpable in this matter; every Circuit Panel had a District Judge (S.D.N.Y.) sitting by designation in order to establish a "Circuit Set-Up Panel". I personally filed ten (10) 28 U.S.C. 351 Judicial Complaints that all the judges hide from. As I stated, I experienced flagrant violations of my Civil and Statutory Rights from oral argument where District Judge Coty sitting by designation on Circuit Panel stated (when I told her she was not following the law "that's it no dialogue". I repeat oral argument "that's it no dialog").

That is a banana republic in act, also as for a good example is Circuit Judge Straub, who not only protected you and Judge Nevas fraudulently post dated documents, he also stated in his opinion that I filed "a motion for a new trial when there was not trial." That fraudulent statement was for the purpose so no one read the pro se filing. On remand when I stated to you on the record "you know I filed no such motion" – you stated "it was not your problem it was Chester Staub". For years now I have been asking

myself what type of low life deviant would do such a degrading thing. His degeneracy must be acted out in other cases and his private life. You can't change the spots on a leopard nor can you take the degenerate out of a degenerate. I filed this instant 5 U.S.C. 552(a)(4)(B) Federal Waiver Complaint March 3, 2009 requesting you or any other judge from the Bridgeport Division not hear the motion. I specifically stated on page 5 and 6 under heading of "Filing." Quoted for Convenience:

This instant 5 USC 552(a) action in the interest of Justice and Canon Law should not be filed in the Bridgeport Division or with any Judge that Senior Judge Alan Nevas has Sub Rosa corrupt influence on by way of corrupt[ed] law clerks. Senior Judge Alan Nevas is one of the primary criminal usurpers of Civil and Statutory Rights obstructing pleadings that exposed the "Operating Agreement" as a criminal scheme (18 U.S.C. 371) doing so through law clerks when he is not even assigned to the case (documented). Senior Judge Alan Nevas was also a U. S. Attorney now Federal Judge. This petitioner also requests in the interest of Justice that this case not be heard by any Federal Judge who was a former U. S. Attorney. This is Separation of Powers Corruption making this filing statement applicable. At this critical time in our country "Public Interest" should be a first priority concerning corruption of the Lawful Functions of the United States.

Similar request in the Second Circuit concerning "D.O.J. Set Up Panels" and the instant Circuit Panel in the Second Circuit concerning this case – another S.D.N.Y. District Judge sitting by designation on the Circuit Panel dismissed another 28 U.S.C. 351 Complaint against you. I am a very ill man and can't play this gypsy shell game with my rights anymore with people who obstruct the Constitution rather than protect it. I acknowledge you and your cabal are above the law and control the press.
